

## **CSC Project Synopsis -- 2012**

**Project Title:** Land Trust Trail Mapping & Coordinated Website for Trail Information

**Goal:** To improve management of public access to protected lands and at the same time promote greater public awareness and use of land trust trails by ensuring that: land trusts with trails open to the public have maps for those trails; and information and trail maps for land trust trails are easily accessible to Rhode Island residents and visitors.

**Brief Description:** One of the primary reasons that land trusts protect land is to provide residents of their community with places to get outdoors. Management of public access to protected lands is important for sound stewardship. Thus, many land trusts develop trails on their protected properties to encourage and manage public use. Another stewardship issue for trails is promoting safe use.

The public is often not aware of the land trust trails that are available for their use and enjoyment right in their home community and on land trust preserves that protect special places across the state. This project proposes to:

- assist 7 land trusts that do not have good trail maps for their trails, develop and produce a trail map; and
- compile information on land trusts trails across the state that are mapped and place them on a common website so that they can be easily located and downloaded by trail users. We propose to expand the ExploreRI website (which currently has canoe access and water "blue" trail information) and add a section on walking trails. Our initial effort will be to provide information on land trust trails. The site can be expanded in the future to add information on other trails. The website will increase the visibility and use of land trust trails across the state. Readily available trail maps will also help land trusts protect sensitive areas by helping visitors to their preserve know where the trails are and stay on the trails instead of walking off the trails into sensitive areas that the land trusts are trying to protect.

**Deliverables:** The deliverables for this project are:

1. PDF maps of trails for 7 land trust properties not currently mapped
2. Set-up for the Explore RI website so that it can accommodate and present information on land trails
3. Information on land trust trails that have maps posted on ExploreRI website.
4. GIS information on trails mapped as part of this project will be provided to RIDEM for addition to the trail database that they are developing for the state.
